If you do not use the **EXACT** organization name as registered with **NATIONAL**, **STATE OR PROVINCIAL** authorities, Interland will then be forced to re-submit your request to Thawte with an organization name correction and new CSR. **THERE WILL BE A \$25 SUPPORT FEE FOR RE-SUBMISSION**. (The organization name is what you must prove.) Thawte also retains the right to revoke your Server ID if you fail to perform any of your material obligations under the terms and conditions for the use of the Authentic Site Seal anywhere you have installed the Authentic Site Seal.
- **3. Obligations Upon Revocation or Expiration.** Upon expiration or notice of revocation of your Server ID, you shall permanently remove your Server ID from the server on which it is installed and shall not use it for any purpose thereafter.
